Off Terminal Yard Storage	Per Container	When a customer requests off terminal yard storage	\$125 + \$50/day	Yes	Import/Export
Overweight Citation/Fine	Per Container	Citation or fine received for container being overweight	Pass through	No	Import/Export
Placard Placement/Removal	Per Container	When service is required to place or remove placards. Applies regardless of number of placards actioned and whether performed by terminal or trucker	\$200	Yes	Import/Export
Premount	Per Container	Assessed for additional chassis-related service requested by customer	\$250	Yes	Import
